Human Trafficking and Pedophilia

I am the victim of what I believe is a prolonged human-trafficking and exploitation operation involving Ramesh Rao, Seokheon Cho, and Yeon-ho Kim. I allege that this operation has subjected me to violence, torture, psychological torment, intimidation, defamation, exploitation, and organized disinformation designed to control me, destroy my credibility, and generate financial benefits for those involved. I further believe that I have been used as a research subject without my consent and that my family, including my seven-year-old daughter, has also been targeted and harmed.

Alleged Pedophile Ring and Exploitation of My Daughter

I allege that people involved in this human-trafficking operation participate in a pedophile ring that collectively exploits children through an online network called “the site.” I further allege that participants create, record, possess, distribute, and share videos and other material depicting the sexual abuse and exploitation of children.

Most seriously, I allege that **my seven-year-old daughter has been a victim of sexual exploitation by people associated with this ring**. She was forced into sexual activity with members of the alleged network without her consent and against my will as her parent. If substantiated, what I am describing would constitute horrific abuse of a child, not consensual sexual activity.

I also allege that individuals associated with this network have deliberately inflicted physical trauma on my daughter in an attempt to impair her cognitive development and reduce her intellectual functioning. This allegation requires urgent medical and forensic evaluation; I cannot determine from my account alone whether she has sustained neurological injury or experienced changes in IQ.

I specifically allege that Ramesh Rao, Seokheon Cho, and Yeon-ho Kim are among those responsible for leading or participating in the broader network. These are extremely serious allegations and require an independent investigation.

Violence, Disinformation, and Control

I believe **violence is deliberately used to control me**, while organized disinformation—including what I allege are false accusations of rape and poisoning—destroys my credibility. In my account, physical violence, torture, threats, intimidation, and psychological torment have diminished my ability to think, function, resist, advocate for myself, protect my child, and escape.

Violence is therefore not incidental to what I describe as human trafficking. **I believe violence is one of the mechanisms through which the trafficking is maintained.**

I believe the violence and disinformation work together. Violence weakens my ability to resist, while defamation attacks my credibility when I attempt to explain what is happening. The people I accuse can then portray themselves to outsiders as legitimate actors or even as people supposedly helping me.

The sustained violence and torture inflicted by participants in the pedophile ring have caused catastrophic damage to my brain. My speech, vocabulary, writing, memory, executive functioning, and ability to independently generate and organize thoughts have deteriorated dramatically. I have difficulty retrieving words and formulating thoughts, experience serious writing problems, and have difficulty accessing languages I previously knew, including Korean and Spanish.

My brain has been reduced to mush. Even the cat's brain was reduced to mush.

I experience profound mental fog, diminished thought, emotional blunting, anhedonia, memory impairment, and severe tremor-like symptoms. These problems interfere with my ability to speak, write, remember, think, plan, experience emotion, coordinate movement, initiate actions, and function independently.

I attribute this deterioration to violence that I believe was deliberately inflicted upon me for purposes of control, exploitation, greed, and financial gain. I believe destroying my cognitive abilities also makes the alleged trafficking easier to sustain. A person whose memory, language, concentration, planning, and independent thought have been severely impaired is placed at an enormous disadvantage when attempting to document abuse, challenge disinformation, protect a child, seek assistance, or escape.

I am additionally concerned about progressive deterioration of my body. I fear that within approximately one year, abnormal ossification or other changes involving my bones could make ordinary movement capable of causing fractures.

Alleged Exploitation of CIA Money

I further allege that participants have attempted to siphon or “farm” money from the CIA by manufacturing narratives in which they portray themselves as legitimate actors supposedly helping me. My existing account describes this alleged scheme and the use of defamation and false-light claims to influence CIA representatives.

I believe participants use these narratives to convince CIA representatives that their conduct is intended to help Michael or force Michael to do what they characterize as “good.” I allege that this manufactured justification is then used to legitimize obtaining government money for the benefit of other participants.

I further allege that extraordinary sums—including representations involving **\$500 trillion**—have been offered or discussed in connection with other participants while I, the person they

supposedly claim to be helping, remain without the assistance necessary to escape what I describe as human trafficking and protect my family.

I also allege that government representatives have been bribed or otherwise financially influenced. I believe maintaining those relationships provides the alleged operation with something extremely valuable: **an appearance of legitimacy**. The people I accuse of harming and controlling my family can portray themselves as our protectors while simultaneously benefiting financially from supposedly “helping” us.

These allegations involving CIA funds, bribery, government representatives, and **\$500 trillion** require independent evidence. Financial and banking records, communications, transaction histories, authorization records, electronic evidence, and witness testimony should be examined.

A System of Exploitation

I believe my family and I are trapped in a system where **violence, child exploitation, money, coercion, and disinformation reinforce one another**. Violence controls me physically and psychologically. Defamation, such as false accusations of rape and accusations of poisoning others, attacks my credibility. False narratives portray the people I accuse as my helpers. Government involvement allegedly provides legitimacy, and that legitimacy is then used to pursue additional money.

The result is a grotesque inversion: **the people I accuse of exploiting my family can portray themselves as the people rescuing us**.

Do not allow disinformation to substitute for evidence.

I am not asking anyone to declare these allegations true simply because I have made them. I am asking for an independent investigation based upon evidence: medical and forensic examinations, medical imaging, financial and banking records, communications, photographs, recordings, electronic records, witness testimony, relevant online activity, and evidence concerning the alleged production and distribution of child sexual-abuse material.

I allege that I am a victim of human trafficking. I allege that violence has been used to control me. I believe I have been tortured, psychologically tormented, subjected to nonconsensual research, defamed, and exploited. **I allege that my seven-year-old daughter has been sexually exploited and deliberately subjected to physical trauma intended to impair her cognitive development**. I further allege that people connected to this operation create and distribute material depicting the sexual exploitation of children.

Please help me and my family.

We need protection rather than exploitation. We need medical care rather than additional violence. My daughter needs protection from anyone who may be sexually or physically harming her. And we need an investigation based upon evidence rather than disinformation.

No amount of money—not even **\$500 million**—can justify destroying another person's brain, body, dignity, independence, or future. No financial interest can justify sexually exploiting or deliberately injuring a child.

My family and I deserve to live free from violence, torture, intimidation, sexual exploitation, coercive control, and human trafficking.
